## **ADMINISTRATIVE CITATION**

#### **Administrative Citation**

Atascadero Municipal Code Title 12 Code Enforcement provides for the issuance of administrative citations for municipal code violations and other applicable codes/laws. Three levels of citations can be issued progressively for a violation. The fines, as indicated on the front of the citation, are as follows:

- \$100.00 for the 1st citation;
- \$200.00 for the 2<sup>nd</sup> citation; and
- \$500.00 for the 3<sup>rd</sup> & subsequent citations for same violation(s) occurring within 1 year of issuance of the first citation.

These fines are cumulative, and citations may be issued for each day that violations exist. A warning, if issued, does not incur a fine and, therefore, may not be appealed.

## **Rights of Appeal**

You have the right to appeal this administrative citation by filing a completed notice of appeal and request for hearing form, together with an advanced deposit of the total fine amount indicated on the citation and a detailed written explanation setting forth the grounds for the appeal, at the city within 15 calendar days from the date of issuance of the citation upon the proper filing of an appeal; the city will schedule an administrative appeal hearing.

Failure of any person to properly file the notice of appeal and request for hearing form within 15 calendar days from the date of issuance of the citation that he or she wishes to contest, together with the advanced deposit of the total fine amount indicated on the citation and detailed written explanation of the grounds for the appeal, shall constitute a waiver of his or her right to an administrative appeal hearing and adjudication of the administrative citation, or any portion thereof, and waiver of the right to contest the amount of the administrative fine assessed.

#### **How to Pay Fine**

The fine is indicated on the front of the administrative citation. Before receiving an invoice from the City of Atascadero, you may pay the fine by mail or in person at the City of Atascadero, 6500 Palma Ave, Atascadero, California 93422. Payment should be made by personal check, cashier's check, or money order payable to the City of Atascadero. Please write the citation number on your check or money order.

If the citation is not paid or appealed within the statutory time, you'll receive an invoice from the City of Atascadero's Administrative Services Department. Please follow the instructions on the invoice to ensure proper payment processing. Payment of the fine shall not excuse the failure to correct the violation, nor shall it bar further enforcement actions by the City of Atascadero.
